### **Medical Release**

The undersigned being the lawful parent(s) of the child named above (the Child) hereby consents to participation of the Child in McLain School of Celtic Arts conducted by Reid McLain (or appropriate substitute) and to the participation of the Child in all events relating to all the activities during the term of enrollment and participation, and ensures that the child is physically able to participate and willfully does so.

The undersigned hereby further authorize(s) any of the employees, agents and representatives of McLain School of Celtic Arts and Reid McLain to provide for, approve, and/or authorize any health care at any hospital, emergency room, doctor's office or other institution; employ any physicians, dentists, nurses or other persons whose services may be needed for such health care; review and if necessary disclose the contents of any medical records; and execute any consent forms required by medical, dental or other health authorities incident to the administration of medical, surgical or dental care to the child. Health care shall include but not be limited to the administration of anesthesia, X-ray examination, performance of operations, diagnostic and other procedures.

If there is no medical emergency, the McLain School agent will first use reasonable efforts to contact the parent(s) and/or guardian(s) before administering or authorizing any treatment.

Notwithstanding that provision in this Consent Form, McLain School of Celtic Arts and Reid McLain shall not have the authority to withhold or withdraw life-sustaining procedures for the Child.

### **Medical Liability Release**

The undersigned assume(s) all risk of injury or harm to the Child associated with participation in McLain School of Celtic Arts and agree(s) to release, indemnify, defend and forever discharge McLain School of Celtic Arts and Reid McLain and its staff, employees and agents (collectively the "Organizer") of and from all liability, claims, demands, damages, costs, expenses, actions and causes of action (collectively the "Claims") in respect of death, injury, loss or damage to the Child or by the Child howsoever caused, arising and to arise or by reason of or during the Child's participation in the McLain School of Celtic Arts.

### **Physical Interaction Understanding**

Parents and guardians must understand some classroom dynamics necessary to create a safe environment both physically and mentally. They must also recognize that these appropriate dynamics are necessary to their child's dance development. In order to correct the child in dance development, appropriate physical interaction will take place. This includes but is not limited to positioning of the feet, hips, legs, abdomen, shoulders, head, arms and hands when verbal instructions fail for any reason to elicit the correct dance position or movement. It is the responsibility of the parent to understand what is appropriate and safe, and to prepare the Child for this interaction. By signing below, parents consent to appropriate physical interaction and are responsible for clarifying what exactly that is, as the very nature of dance involves physical interaction. McLain School of Celtic Arts seeks to provide a safe classroom for dance development for all members.

**General Liability Release**
